

# DECLARATION

I (the policyholder), and on behalf the Insured Student hereby declare as follows:

1. I understand and agree that only (i) the parent of the Insured Student, (ii) Legal Guardian of the Insured Student, or (iii) Insured Student who is aged 18 or above can be the policyholder, and I confirm that I am eligible to be the policyholder. I (policyholder) declare that the statements and particulars given in this application are to the best of my knowledge and belief, true and complete and that this application will form the basis of my contract with AXA General Insurance Hong Kong Limited ("AXA").
2. I further declare that:
  - (i) I have the full authority from and consent of the Insured Student to make the declarations, agreements and authorizations included in this insurance application, or I am the Insured Student under this insurance application.
  - (ii) The Insured Student and I are both in Hong Kong SAR when applying for this insurance.
  - (iii) The Insured Student is a full time overseas student (attending day courses), in good health, and will not be travelling contrary to the advice of medical practitioner, and/or for the purpose of obtaining medical treatment or for migration, and/or engaging in any manual work during the Period of Insurance.
  - (iv) The Insured Student does not have physical impairment or mental deficiency, and has never been treated for or examined that he/she has abnormal blood pressure, ulcers, tuberculosis, mental disorder, thrombosis, hernia, diabetes, cancer, varicose veins, venereal disease, paralysis, arthritis, rheumatism, any disorder or disease of nervous, genito-urinary system, spine or heart.
  - (v) The Insured Student is not insured under any in force Overseas StudySurance or any other insurance policy of similar nature issued by AXA for the same Study Trip under this application; and no insurer has ever cancelled, declined, refused to renew or imposed special terms or conditions on any medical, travel and/or overseas student insurance policy held by Insured Student/myself.
  - (vi) The Insured Student and I do not have any address or residence in Japan.
3. (Applicable to application via HSBC staff in branch) I have read and understood the Factsheet & FAQs of Overseas StudySurance I applied for.  
  
(Applicable to application via HSBC website) I have read and agreed with the Terms of Use, Declaration, Factsheet & FAQs, Policy Wording, Privacy Policy Statement and Personal Information Collection Statement.
4. I/We agree AXA will use my/our personal details such as corresponding address, email address or mobile number to send me/us policy-related information and documents by mail or merely by electronic means (such as by email or SMS) at AXA's discretion.

I/We confirm that I/we have been advised to read carefully the PICS, and I/We have read it carefully its effect and impact in respect of my/our personal data collected or held by AXA (whether contained in this application or otherwise). Based on the foregoing, I/We hereby give my/our acknowledgement and agree to the use and transfer of my/our personal data by AXA in accordance with the PICS.
