2. **Who can enjoy the Promotion:** The offers under this promotion (collectively, the "Offer") are exclusive to personal customers who are the sole or principal accountholder (if a joint account) of a Hong Kong Dollar Statement Savings Account – Children Savings Account or Premier Junior Pack (the "Applicable Account") of The Hongkong and Shanghai Banking Corporation Limited in the Hong Kong Special Administrative Region ("Hong Kong") (and its successors and assigns) (the "Bank" or "HSBC") as of 17 February 2020 and fulfil all the following requirements (the "Eligible Customers"):
