# (Individual/Joint Account - Mailing Approach for Hong Kong Permanent Resident)

# General guidance 一般注意事項

- 1. Please do not send us originals of your identity documents. All documents submitted to us will not be returned. 請不要遞交任何正本的身份證明文件,所有遞交的文件將不會退回。
- 2. Please ensure that you date (where applicable) and sign all forms and agreements before returning them to us. 寄回文件及合約前,請確保每份文件填上簽署日期(如需要)及已簽署所有表格及合約。
- 3. Please initial next to any changes you make to any pre-filled information in any form or agreement. 如有刪改任何表格或合約上的資料,請於刪改之位置旁簽署。
- 4. We cannot accept any changes to the terms of the Customer Agreement or Terms of Business. 本公司不接受任何有關商業條款的更改。
- We may request additional information and documents during the account opening process.

- 6. If you would like to appoint a person to give us trading instructions or instructions to withdraw money and/or securities from your account on your behalf, please contact your Account Executive after your account is open. 如若委任授權交易人或 / 及授權提取款項及 / 或證券代表(統稱「有關人士」),可於滙豐金融戶口成功開立後與客戶經紀聯絡。
- 7. We are only able to accept instructions to withdraw funds to (a) an Account Holder's HSBC bank account and/or (b) the bank account of a cheque provided as item 6 under Mandatory Account Documentation in the Documentation List. We call this your "Designated Bank Account". If you would like to change your Designated Bank Account, please contact your Account Executive after your account is open.

3. Personal cheque for HKD 10,000 (item 5 under Mandatory Account Documentation in the Documentation Checklist) 港幣一萬元的個人支票 (文件清單中第5項)

The cheque must satisfy the following requirements:

- a) It must bear the name(s) of the Account Holder(s) as shown on the identity card(s) provided to us; 支票必須載有戶口持有人在身份證明文件上所顯示的姓名

- c) The signature(s) on the cheque must match the signature on all the account opening documents; and 支票上的簽名必須與客戶合約和所有開戶文件的簽名相符; 及
- d) It must be payable to "HSBC BROKING SECURITIES (ASIA) LIMITED" 支票抬頭須注明「滙豐金融證券(亞洲)有限公司」

For joint Account Holders that do not have a joint bank account, we will need a cheque from each Account Holder. (只適用於聯名戶口) 如支票不是聯名銀行戶口,請每位戶口持有人各提供一張符合以上條件的支票。

4. Written consent from employer (item 6 under Mandatory Documentation in the Documentation Checklist) 僱主同意書 (文件清單中第 6 項)

If any Account Holder is a licensed representative or responsible officer of a licensed corporation; a relevant individual or executive officer of a registered institution; an employee of a licensed corporation or registered institution; or an employee of HSBC Global Services (Hong Kong) Limited, that Account Holder must provide written consent from their employer.<sup>2</sup>
