1. What needs to be provided to HSBC Life (International) Limited to verify the domestic partner status?

您需要提供甚麼給滙豐人壽保險(國際)有限公司來證明固定伴侶的身份？

If you wish to nominate your domestic partner (as defined in point 2 below) as a beneficiary under your life insurance policy, ONE of the following supporting documents has to be provided to HSBC Life (International) Limited for consideration during the nomination process:

(a) A declaration of the domestic partnership at the Home Affairs Department of the Hong Kong HKSAR Government (“HAD”). HAD provides a free service for the administration of declarations for private use covering both HK citizens and overseas passport holders; OR
