## 宏觀及市場回顧 Macro and market review



- 由於烏克蘭衝突產生溢出效應，加上中國因應新型冠狀病毒(COVID-19)疫情而實施封城，削弱風險胃納，環球股市於四月下跌。政府債券方面，通脹數據高企令投資者預料當局會採取較強硬的政策，美國及歐洲債券下跌(孳息率上升)。十年期德國政府債券孳息率接近1%的水平，十年期美國國庫券孳息率則接近3%。短期債券月內亦報跌。商品方面，供應憂慮持續導致價格大幅波動，石油價格進一步上漲。與此同時，市場預期聯儲局將採取較進取的緊縮政策以應對通脹，黃金因需求減少而下跌

Global equities fell in April as spillovers from the conflict in Ukraine, combined with coronavirus disease (COVID 19) -related lockdowns in China, dampened risk appetite. For government bonds, US and European bonds fell (yields rose) as high inflation readings raised investor perceptions of more hawkish policy. German 10-year bund yields floated close to the 1% mark, while US 10-year Treasury yield approached 3%. Short-dated bonds also fell during the month. On the commodities front, oil ended higher amid volatile price moves following continued supply-related concerns. Meanwhile, gold declined as expectations of a more aggressive Federal Reserve (Fed) tightening path to combat inflation reduced demand

The combination of slower growth and higher inflation is a challenge for many policy makers, and this will be exacerbated by rising energy prices. In the mid-part of the economic cycle, there will also be policy divergence

We expect a total of 225 bps of Fed rate hikes in 2022 with quantitative tightening beginning in May. US fiscal policy will also be a drag on growth

- 在中國，增長風險預示要採取更果斷的政策寬鬆措施。我們預計當局會進一步放寬信貸控制及推出逆周期財政政策，以提振信貸增長

In China, growth risks call for more decisive policy easing. We expect a further easing of credit controls and counter-cyclical fiscal policy to boost credit growth

## 資產類別展望及策略 Asset class outlook and strategy



- 股票方面，通脹持續高企預料會令實際收入受壓並削弱消費者信心，而商品價格高企預料會拖累邊際利潤。儘管如此，風險溢價仍然吸引，故適宜採取以因素為本的選股方針

For equities, continued high inflation is likely to squeeze real incomes and worsen consumer confidence, while high commodity prices are likely to weigh on profit margins. Nevertheless, risk premia look attractive and a selective, factor-based approach can be suitable

- 在英國及美國等已啟動加息周期的地區，政府債券的估值變得較為吸引。假如增長轉弱導致央行減慢加息步伐，孳息率仍有一些下行風險

The valuations of government bonds have become much more attractive in regions that have commenced rate hiking cycles such as the UK and the US. There remains the risk of some downside pressure on yields should weaker growth lead to central banks hiking less aggressively

- 企業債券方面，儘管企業基本面惡化，但年初至今息差擴闊創造了取得利差的良機。預期高於趨勢水平的增長會為短期前景提供支持

For corporate bonds, despite worsening corporate fundamentals, spread widening year-to-date has opened up good carry opportunities. The near-term outlook is supported by above-trend growth prospects

### 股票 Equities

#### ■ 環球股票 Global Equities

增長前景惡化不利支持環球股市。烏克蘭衝突和中國的封城措施導致供給側持續受阻，使短期前景受壓，但風險溢價吸引和邊際利潤的緩衝有助支持股市

A worsening growth outlook is less supportive for global equities. Lingering supply-side disruptions caused by the conflict in Ukraine and lockdowns in China dampen the near-term outlook, but attractive risk premia and margin buffers support the case for equities

#### ■ 亞洲日本除外股票 Asia ex Japan Equities

美國孳息率上升、滯脹風險、利潤率壓力和外圍需求不確定性的前景構成擔憂，但估值具支持性，反映了宏觀／盈利風險。在政策正常化下，經濟重啟和資本開支有利復甦。中國的政策明朗化具利好作用

Prospects of higher US yields, stagflation risks, margin pressures and external demand uncertainty are concerns, but valuation is supportive, pricing in macro/earnings risks. Economic re-opening and capital expenditure aid the recovery amid policy normalisation. China's clear policy put is a positive

#### ■ 美國股票 US Equities

美國股票估值相對較高，意味著需較為審慎，但一些板塊變得便宜，意味預期夏普比率現時較高。投資優質股、大型科技股和數碼經濟為防守型資產配置的一部分

US equity valuations are relatively high which implies some caution, but parts of the market have cheapened and that means that prospective Sharpe ratios are now higher. Exposure to quality names, mega-cap tech and the digital economy is part of a defensive asset allocation

#### ▼ 歐元區股票 Eurozone Equities

歐洲股市受惠於價值。歐洲股票的估值大跌，但宏觀經濟前景惡化，且信心下降和投入價格上漲壓縮利潤率帶來風險，意味著需要審慎篩選

European equities benefit from value. European stocks have cheapened a lot, however a deteriorating macroeconomic outlook and the risk of margin compression as confidence drops and input prices rise implies caution

#### ▲ 中國股票 Chinese Equities

在全球金融環境收緊下，房地產低迷和監管／COVID-19疫情政策的影響持續，使短期宏觀和盈利繼續受到壓力，但估值極具吸引力。當COVID-19疫情的打擊開始減退，政策支持可能有助盈利最終復甦

Near-term macro and earnings pressure remains from the property market downturn and regulatory/COVID-19-policy overhang, amid tighter global financial conditions, but valuations are highly attractive. Policy tailwinds may help an eventual earnings recovery as COVID-19 impacts start to fade

#### ▲ 香港股票 Hong Kong Equities

市場在金融業的佔比可望受惠於利率上升。COVID-19疫情、地緣政治和商品通脹在短期內有風險，但財政刺激和最終重新開放邊境應有利周期復甦。融入大灣區／中國內地的「十四五」規劃有利長遠增長

The market's exposure to the financials sectors could benefit from interest rate rises. Near-term risks exist from COVID-19, geopolitics and commodity inflation, but fiscal stimulus and an eventual border reopening should help a cyclical recovery. Greater Bay Area integration/mainland China's Five-Year Plan aids long-term growth

### 債券 Bonds

#### ■ 環球政府債券 Global Government Bonds

市場重新評估政策正常化，令估值有改善。通脹高企仍然是主要風險，但假如增長大幅停滯，孳息率有下降空間

Valuations have improved amid market repricing of policy normalisation. Sticky inflation remains a key risk although there is scope for yields to fall if there is a meaningful stalling in growth

#### ■ 美國政府債券 US Government Bonds

孳息率近期上升，但假如增長預期較預期低，市場可能重新調整對聯儲局加息的觀點，這可能使孳息率下降。假如通脹保持在目前的數十年高位，將需面對上行風險

Yields have risen recently, but may fall should there be a reassessment of Fed rate hike views in light of weaker than expected growth expectations. Upside risks do exist should inflation remain at their current multi-decade highs

# 從2019年7月1日起，滙豐強積金自選計劃(「自選計劃」)已合併入滙豐強積金智選計劃(「合併」)。就合併而言，六項成分基金，即自選均衡基金、環球股票基金、自選美國股票基金、自選歐洲股票基金、自選亞太股票基金及恒生中國企業指數基金，已於滙豐強積金智選計劃下成立。

With effect from 1 July 2019, HSBC Mandatory Provident Fund – ValueChoice (‘ValueChoice’) has been merged with HSBC Mandatory Provident Fund – SuperTrust Plus (the ‘Merger’). For the purpose of the Merger, six Constituent Funds, namely, ValueChoice Balanced Fund, Global Equity Fund, ValueChoice US Equity Fund, ValueChoice European Equity Fund, ValueChoice Asia Pacific Equity Fund and Hang Seng China Enterprises Index Tracking Fund have been launched under HSBC Mandatory Provident Fund – SuperTrust Plus.

From 26 November 2021, the ValueChoice Europe Equity Tracker Fund was renamed from the ValueChoice European Equity Fund. From 3 December 2021, the Chinese name of the ValueChoice Balanced Fund was changed while its English name remained the same. The investment objectives and balances of investments of the above Constituent Funds were changed effective from the respective aforesaid dates.
