# 宏觀及市場回顧 Macro and market review



隨著投資者消化多國央行進取的加息步伐,環球股市於九月下跌。對經濟衰退的憂慮與日俱增,加上環球盈利前景降級,進一步打擊市場情緒。隨著投資者開始在價格中反映主要央行較進取的加息步伐,環球政府債券下跌(孳息率上升)。通脹較預期頑固並且仍然居高不下。經歷近期的財政事件後,英國固定收益市場尤其波動。商品方面,環球經濟放緩繼續拖累需求前景,大多數商品價格報跌。隨著政策措施舒緩了外界對供應短缺情況的憂慮,歐洲的天然氣價格有所下降

Global equities fell in September as investors digested aggressive rate hikes from several central banks. Growing recession concerns and global earnings downgrades further dampened sentiment. Global government bonds fell (yields rose) as investors began pricing in more aggressive rate hike trajectories from major central banks. This came amid stickier-than-expected and still-high inflation. UK fixed income markets were particularly volatile following the recent fiscal event. On the commodities front, most commodity prices declined as a global slowdown continued to weigh on the demand outlook. European gas prices fell as policy measures eased concerns over the extent of supply shortages
