宏觀及市場回顧 Macro and market review



環球股市在六月廣泛上揚,未有受持續政策不確定性和地緣政局緊張所影響。美國十年期 國庫券孳息率保持高企,美元則進一步轉弱,使新興市場資產受提振。信貸市場方面,投 資級別和高收益信貸的息差收窄。黃金價格在月中創新高。政府債券方面,美國國庫券孳 息率於六月下降,但仍維持在偏高水平,原因為聯儲局保持利率穩定,且市場對潛在通脹 風險和政府赤字擴大保持警惕。地緣政局緊張對孳息率的影響有限。股票方面,美國股市 回升至新高,而美元疲弱有助新興市場表現領先。南韓和台灣股市表現穩健,前緣市場亦 表現良好。另類投資方面,上市房地產延續年初至今的強勁表現,六月錄得正回報。原油 價格於地緣政局緊張下略升,黃金價格接近新高

Global stock markets delivered broad-based gains in June despite continuing policy uncertainty and geopolitical tensions. US 10 Year Treasury yields remained sticky, while the US dollar saw further weakness, which boosted emerging markets (EM) assets. In credit markets, investment grade and high yield spreads tightened. Gold prices reached a new high mid-month. For government bonds, US Treasury yields fell in June but remain relatively high, with the Federal Reserve (Fed) holding rates steady, and markets wary of potential inflation risk and widening government deficits. Geopolitical tensions had limited impact on yields. For equities, US stocks ground their way back to new highs, but US dollar weakness helped EM outperform. South Korea and Taiwan delivered solid gains, with Frontier markets also doing well. For alternatives, quoted real estate continued its robust performance year-to-date with a positive return in June. Crude oil prices edged higher amid geopolitical tensions, and gold traded close to new highs
