

Terms and Conditions for HSBC Reward+ Red Hot Stamp Card Reward at MCL Cinemas

When can you enjoy the offer

- 1. The promotional period for the offer is from 1 February to 31 December 2025, and will be divided into 4 phases:
 - a. Phase 1: 1 February to 31 March 2025
 - b. Phase 2: 1 April to 30 June 2025
 - c. Phase 3: 1 July to 30 September 2025
 - d. Phase 4: 1 October to 31 December 2025

What is the offer

- 2. During the promotional period, use your personal primary card of HSBC Red Credit Card, the Eligible Credit Card, to make an Eligible Transactions with Net Spending Amount of HK\$50 or above at Participating Merchants to earn and collect one stamp via HSBC Reward+ stamp card function. Every 3 stamps collected can instantly redeem an extra \$30 RewardCash via HSBC Reward+.
- 3. You can earn maximum1 stamp per day, and up to maximum of 9 stamps per phase to redeem a maximum of an extra \$90 RewardCash in each phase. You can earn a maximum of 36 stamps throughout the promotion period to redeem a maximum of an extra \$360 RewardCash.

- 17. **'Eligible Credit Card'** means the personal primary card of HSBC Red Credit Card issued by The Hongkong and Shanghai Banking Corporation Limited in Hong Kong (and its successors and assigns). Please note that any additional HSBC Red Credit Card is not eligible for this promotion.
