

Terms and Conditions for HSBC Reward+ Red Hot Stamp Card Reward - McDonald's

When can you enjoy the offer

1. The promotional period for the offer is from 1 January 2025 to 31 December 2025.

What is the offer

- 2. During the promotional period, use your personal primary card of HSBC Red Credit Card, the Eligible Credit Card, to make an Eligible Transaction with Net Spending Amount of HK\$30 or above at the Participating Merchants to earn and collect one stamp via HSBC Reward+ stamp card function. Every 4 stamps collected can be instantly redeemed for an extra \$20 RewardCash via HSBC Reward+.
- 3. You can earn maximum 1 stamp per day, and up to maximum 8 stamps per month to redeem a maximum of an extra \$40 RewardCash each month. You can earn a maximum of 96 stamps throughout the promotion period to redeem a maximum of an extra \$480 RewardCash.
- 4. Stamps earned in each month can only be redeemed within the same month with a grace period of 20 calendar days (see table below). Stamps earned in different months cannot be combined to redeem the extra RewardCash. In the event that the stamps are not redeemed by the end of the 20-day grace period, the stamps will become invalid. How can you enjoy the offer

- d. pay with an Eligible Credit Card for any Eligible Transaction at the Participating Merchants during the promotional period.

- 7. The stamp earned will be reflected on HSBC Reward+ stamp card detail page within 3 working days after the Eligible Transaction has been posted on our system.

- 9. You have to keep all original sales slips of the Eligible Transactions. Eligible Credit Card numbers must be clearly shown in the original sales slips. In case of dispute, we may at any time ask you to submit these slips, and/or further documents or evidence for inspection and we may keep them.
- 10. If any transaction where the extra RewardCash was awarded is subsequently reversed, voided or cancelled, we may deduct the said extra RewardCash from the Eligible Credit Card account and this will be reflected in your card statement.

What these terms mean

- 16. 'Participating Merchants' mean McDonald's restaurants and the McDonald's App in Hong Kong.
- 17. **'Eligible Credit Card'** means the personal primary card of HSBC Red Credit Card issued by The Hongkong and Shanghai Banking Corporation Limited in Hong Kong (and its successors and assigns). Please note that any additional HSBC Red Credit Card is not eligible for this promotion.
- 18. **'Eligible Transactions'** are purchases made in Hong Kong dollars with an Eligible Credit Card with a minimum Net Spending Amount of HK\$30 each at the Participating Merchants during the promotional period and posted on our system during the offer fulfilment period. The transaction date is tracked based on the transaction date in our records as provided to us by the Participating Merchants. You will be able to view the transaction date in your card statement. These are not Eligible Transactions:
 - transactions (including top-up transactions) made via e-wallets;
 - all unposted/cancelled/refunded transactions.
- 19. **'Net Spending Amount'** means the final transaction amount charged to the Eligible Credit Card after all applicable discounts, reductions and use of vouchers/gift cards.
- 20. 'HSBC Reward+' refers to the HSBC HK Reward+ mobile application.
- 21. 'Registration' means the successful registration of an Eligible Credit Card via the HSBC HK Reward+ mobile application.
